The following activities shall not form part of the CSR activities of the company:

1. The activities undertaken in pursuance of normal course of business of a company

2. CSR Projects /programs or activities that benefit only the employees of the company and their families

3. Any contribution directly/indirectly to political party or any funds directly towards political parties or political causes.

4. Any CSR Projects/Programs or activities undertaken outside India.

CSR Committee

CSR Committee shall be formed as per the applicable laws and the committee shall be responsible for the implementation/monitoring and review of this policy and various projects/activities undertaken under the policy. The CSR committee shall submit periodical reports to the board of directors.

CSR spend/sources of funding

The committee shall endeavour to spend at least 2% of the average net profit during the preceding 3 financial years on CSR activities as enumerated the Companies (Corporate Social Responsibility) Rules, 2014. The allocation of the fund shall be made as follows:

1. NATCO Trust - such amount as may be sanction by the board of directors based on their annual budget-the amount sanction by the board of Natco will have to be utilised for the projects/programs as specified by the CSR committee of Natco. The unspent amount, if any at the close of the financial year shall be retained by NATCO Trust and shall be spent only on specified projects/programs.

2. Others-as decided by the CSR Committee based on the evaluation of specific projects/activities.

Any surplus arising out of the contribution made for CSR Activities shall not form part of the business profit of the company and redeployed for such activities.

Implementation

Project/programs covered under CSR activities shall be implemented by

- a) Natco Trust, CSR arm of the company.
- b) In collaboration with other like-minded organisations
- c) Any other institutes, NGOs Government, semi-government, autonomous bodies, trusts etc. however any such projects/programs to be undertaking through these entities shall have an established track records of 3 years of undertaking such projects/programs.

The time period/duration of each projects/programmes shall depend on its nature, extent of coverage and intended impact of such activity.



Monitoring & Reporting

The CSR Committee will be responsible for the monitoring CSR activities and report to the board from time to time.

The CSR Committee has the powers to:

- Seek monitoring and implementation report from the organisation receiving funds.
- Delegate a designated company official to co –ordinate with the organisation receiving funds to inspect the activities undertaken and ensure information in a timely manner.

The following processes will be followed:

a) The activities and budgets for CSR will be presented in details to the committee for NATCO Trust CSR Initiatives

Additionally, the committee may empower the CEO and CFO to spend such amount as they think appropriate for some other strategic CSR contingencies that may arise during any financial year. The amount spent as above shall be put up for ratification of the committee at its next meeting and shall report to the board accordingly.

- b) Continuous Monitoring
 - The committee members will receive in a prescribed format, a quarterly report of CSR Spend;
 - A presentation on the progress of the CSR projects/activities will be made to the committee by the CSR Executives at the committee meeting held from time to time;
 - An annual presentation will be made to the committee which will also include the details of the projects/activities planned for the next year and its respective budgets;
 - The Board of Directors of Natco Trust shall review the implementation of CSR every six months;

Disclosures

The Annual Report of the company shall include a section on CSR outlining the details about the policy developed and implemented by the Company on CSR initiatives undertaken by the Company, the CSR spend during the financial year and other information as required by the prevailing law.
